Per Vermont State Statute: The trustees cannot remove an elected official unless they're (elected official) moving out of town, death or insanity. In addition, by state mandate, vacancies for town office (in which the Library is a municipal library) are appointed by the Select Board. The Trustees will not move

forward with the proposed changes outlined in the January and February minutes related to Section 3 Membership and Section 6 Meetings.

• By-Law Change to Section 9: Amendments:

The trustees will move forward with the Warned change to Section 9 Amendments. Section 9 states: "These By-Laws may be amended by two-thirds majority vote of the members of the Board, provided that the proposed amendment shall have been included in the notice of the meetings".

These By-Laws may be amended by a <u>simple majority</u> vote of the members of the Board, provided that the proposed amendment shall have been included in the notice of the meetings. **Approved**
